NEW CALIFORNIA STATE JOINT RESOLUTION OF THE SENATE AND ASSEMBLY

A RESOLUTION TO RESTORE PARENTAL RIGHTS AND AUTHORITY

Legislative Background for Senate Resolution 19-

.

"The Legislature finds and declares that all children and youth, regardless of gender, class, race, ethnicity, national origin, culture, religion, immigration status, sexual orientation, or ability, have inherent rights that entitle them to protection, special care, and assistance, including, but not limited to, the following: The right to parents, guardians, or caregivers who act in their best interest. The right to form healthy attachments with adults responsible for their care and well-being. The right to live in a safe and healthy environment. The right to social and emotional well-being. The right to opportunities to attain optimal cognitive, physical, and social development. The right to appropriate, quality education and life skills leading to self-sufficiency in adulthood. The right to appropriate, quality health care." CA SB18

In SB18, a group is referred to: The Peninsula Partnership Leadership Council. This Council has already written a children's bill of rights, and SB18 is saying this is the model. This is the framework. This is the pattern they're following. The Peninsula Partnership Leadership Council (PPLC) is composed of the San Mateo County Superintendent of Schools, the County Board of Supervisors and the Silicon Valley Community Foundation. The SILICON VALLEY COMMUNITY FOUNDATION is a non-profit that has assets of \$7.3 BILLION. It runs 1800 philanthropic funds. Here are some of its corporate partners:

Alexza Pharmaceuticals. Microsoft. Pepsico Foundation. Cisco. Hewlett Packard. Dell. Symantec. Unilever. Plus something called the SV2 Silicon Valley Social Venture Fund, "building and scaling social inventions."

This huge Foundation is pushing a children's bill of rights that is reflected in a recent bill, SB18, that will eventually make the State the controlling force over all children in California. It is obvious that these corporate partners will reap enormous profits by creating this model framework. And beyond that, this is their version of a MASSIVE social engineering program. And that program is designed to usurp the traditional authority of the family through a technocratic movement to plan, format, and run the lives of the population from cradle to grave, because these hi-tech scientists and engineers know best.

It is New California's declared determination to reverse the destructive progressive attack on the nuclear family through their education agenda currently adopted within the entire administrative state, and within the education curriculum as mandated in practice within the California state social services structure. This attack stems from the influential work and writings of dedicated collectivists (Marxists) who believe that statist control of the family is the only means to achieve their ideological ideals.

NEW CALIFORNIA STATE SENATE RESOLUTION NO. 19-

A Resolution of the Senate of New California State

Whereas, natural law and natural law's God has established the natural family; and

Whereas, children are placed under the authority of their parents; and

Whereas, children belong to their parents not to the state; and

Whereas, parents are responsible for the education and training of their children not the state; and

Whereas, parental authority is delegated authority and children are stewardships from nature's God to be raised in loving homes and directed into productive contributing members of society; and

Whereas, the authority of parents empowers them to act, decide, judge and set policies for the benefit and protection of their children; and

Whereas, the responsibility of parents includes setting boundaries and limits for the protection of their children until the child reaches the age of accountability; and

Whereas, the education system in California under SB18 and AB329 (which is now enshrined as law in Education Code 51930 and 51939) violates parental rights and usurps parental authority; and

Whereas, the comprehensive sex education program under California Healthy Act framework works to destroy parental involvement in the upbringing of their children; and

Whereas, the current education system undermines and destroys the basic fundamental foundation of our rights by including language in our laws, such as AB329 that prohibits any instruction that would include religious doctrine, including any moral notions that limit the bounds of behavior and personal conscience, as well as historical lessons of fact that would expose the corruptive effect of a socialistic radical narrative. As there are requirements to include discussions about sexuality, transgender feelings and issues, and sexual practices connected to those issues. This, as a consequence, forces parents who become aware of what is being taught in our schools, and must forcefully intercede between their children and the school, and thereby creates an atmosphere of interdiction and legal challenges at a cost to the parents.

BE IT RESOLVED by this joint resolution of the Senate and Assembly members of New California declare that in every public school parental rights and authority shall be restored and the classroom shall be returned to the original purpose of education and personal improvement and achievement, and shall abandon any emphasis of radical ideals that inhibit or diminish the role and rights of the family; and
