Are An Effective Remedy For The Poor Th

- An Affidavit is a written document that records the facts of a grievance or loss
- Your grievances/losses can be accurately and legally documented with Affidavits

The Affidavit Process

- Complete and submit your affidavit document to us today
- We will submit your affidavits by the end of July
- Once served, the Affidavit recipient has only 10 days to respond directly to you, the "Affiant"
- If you receive a response during the 10-day window, you need to let us know ASAP
- If no response, your affidavit is then handed to the OC Sheriff for investigation

Why Affidavits are Important

- If investigation proves your grievance valid, the office holder can be removed from office by the OC Sheriff
- Affidavits provide an expedient way to remove incompetent office holders without partisan bias

- The OC BOS regards themselves as a subsection of the state so they rubber stamp everything coming from above
- OC BOS refuses to answer why they are continuing the state of emergency
- OC BOS has violated their oath of office for the County and to the Constitution by going along with lockdowns

Our Efforts Are Already Paying Off

- The OC BOS is threatened by the resistance they are facing
- They have attempted to silence us by limiting public comment at the BOS meetings
- A recent last-minute agenda item has removed the public's right to address its government—violating first amendment rights to free speech
- The BOS has labeled individual public commentary "unnecessary repetitions" and has limited comments to one "spokesperson" who would speak for everyone
- This is more important than just "moving the needle"—they want to SILENCE US FOREVER!!!
