# State of New California **NOTICE** <u>TO ALL CALIFORNIANS!</u> <u>Chapter II</u> **Grievance 92**

**JANUARY 25, 2022** 

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

#### **Statement of Intent**

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

*"We are determined to live under a State Government in the United States of America and under the Constitution of the United States."* 

### New California Declaration of Independence of January 15, 2018 states:

When a long train of abuses and acts to seize and hold the people's power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their **Right, it is their Duty**, to throw off such Government, and to provide new Guards for their future security.

#### **Preamble of the New California State Constitution states:**

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

#### **First Amendment of the United States Constitution states:**

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourth Amendment of the United States Constitution states:

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

# Grievance 92

#### **Declaration of Grievance Statement of Facts**

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

#### **CALIFORNIA STATE VIOLATES:** United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

#### **United States Constitution Article VI**

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

#### **First Amendment, United States Constitution**

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

#### **Fourteenth Amendment, United States Constitution**

<u>Section 3</u>. No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.

# ORDER OF THE DAY STOP SEDITION

#### **EVIL IN THE "PROVINCE" OF CALIFORNIA**

#### Sedition:

...is overt conduct, such as <u>speech</u> and <u>organization</u>, that tends toward <u>rebellion</u> against the established order.

Sedition often includes <u>subversion</u> of a <u>constitution</u> and <u>incitement</u> of discontent toward, or <u>insurrection</u> against, established authority. Sedition may include any commotion, though not aimed at direct and open violence against the laws. Seditious words in writing are <u>seditious libel</u>.

Because sedition is overt, it is typically not considered a subversive act, and the <u>overt</u> <u>acts</u> that may be prosecutable under sedition laws vary from one legal code to another.

## A seditionist is one who engages in or promotes the interest of sedition.

Sedition is a crime in the United States under 18 U.S.C.A. § 2384 (2000), a federal statute that punishes seditious conspiracy, and 18 U.S.C.A. § 2385 (2000), which outlaws advocating the overthrow of the federal government by force.

The crime of seditious conspiracy is committed when two or more persons in any state or U.S. territory conspire to levy war against the U.S. government. A person commits the crime of advocating the violent overthrow of the federal government when she willfully advocates or teaches the overthrow of the government by force, publishes ma terial that advocates the overthrow of the government by force, or organizes persons to overthrow the government by force. A person found guilty of seditious conspiracy or advocating the overthrow of the government may be fined, sentenced to up to 20 years in prison. States also maintain laws that punish similar advocacy and conspiracy against the state government.

#### For those who don't understand the United States Constitution the "Government" is "We the People".

The evidence is now clear that acts of sedition are on display daily against We the People the people. Not only on the federal level but on the state and local level as well from City Council, county Board of Supervisors, School Boards which have become hot beds of open sedition against all of their constituents.

#### The overt nature of their totalitarian lust for control of every aspect of the lives of "We the People" is now a deadly blood lust.

At the state level California has been returned to provincial status by seditious defaulting in its obligations to fulfill its Constitutional responsibility under *Article IV, Section 4 and Article VI* of the U.S. Constitution.
