# Grievance 87

DECEMBER 21, 2021

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

### Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

*“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”*

### New California Declaration of Independence of January 15, 2018 states:

*“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.*

*When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future security.*

## **Preamble of the New California State Constitution states:**

*We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....*

## **First Amendment of the United States Constitution states:**

**"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."**

## **Fourth Amendment of the United States Constitution states:**

**The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.**

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

# Grievance 87

### Declaration of Grievance Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

#### United States Constitution Article IV Section 4

*This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.*

**Section 3.** *No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.*

# ORDER OF THE DAY

## DEFUND LAW ENFORCEMENT

Now that California is in economic and constitutional default the cutting of budgets and programs has begun. Living in a Communist state such as California the “logical” place for California Communists to cut is law enforcement and prosecutions. Good Communists will never pass up the opportunity to destabilize a state or country with the systematic removal of all elements of law and order would include the removal of not just law enforcement but also the prosecution of laws.

On October 8, 2014 then Lt. Governor of California, Gavin Newsom wrote a blog to announce he would run his entire campaign for Lt Governor on the promotion of lawlessness as he would be the champion of California’s “Prop 47”.

*“This fall, as usual, California voters will consider a number of initiatives (changes in the California Constitution) on the ballot. One of them, Prop 47, is controversial – but it shouldn’t be. Here’s why. Prop 47 will change the way we sentence people in California for non-violent, low-level crimes like drug possession and petty theft. Today, those offenses often carry felony charges, but Prop 47 will change them to misdemeanors. . It’s a common sense rebalancing of our criminal justice system so that it prioritizes violent and dangerous crimes. Even better, by reducing prison costs, Prop 47 will save hundreds of millions of dollars every year – and use those savings to break the crime cycle”.*

Communists are great at “double speak” and the good Communist Gavin Newsom is no different. Virtually everything stated in the above blog post by Newsom from 2014 has turned out to be wrong. For *“non-violent, low-level crimes like drug possession and petty theft”* smash and grab crimes are now a common crime on the streets of California followed by home invasions and petty theft that allows criminals to steal as much as \$950.00 and not face a felony charge just a citation. In Newsom’s words *“Today, those offenses often carry felony charges, but Prop 47 will change them to misdemeanors. That’s a good thing.”*

For us New Californians we see through Newsom’s Communist double speak and so does law enforcement and good prosecutors around the state.

Los Angeles Sheriff Alex Villanueva said Tuesday that his department is underfunded and understaffed during a time that Los Angeles County is in need of “more law enforcement presence” to ensure public safety.

The sheriff said during a press conference that he’s concerned with rising violent crime, as the department is in the midst of a hiring freeze, combined with staff retirements or leaving to other departments. This year’s budget removed 1,281 positions, not including 379 sworn retirements so far this year, Villanueva said.

“We are shrinking as a law enforcement agency,” he said. “At a time when we need more law enforcement presence.” *There have been 236 homicides from Jan. 1 to Oct. 31 this year, a 46.6 percent increase compared to last year, according to the Sheriff's Department statistics.*

Again Newsom from his 2014 reelection blog endorsement of Prop 47: *“It’s a common sense rebalancing of our criminal justice system so that it prioritizes violent and dangerous crimes.”*

Its not just the enforcement of law its also the prosecution of the law. From the December 13, 2021 Epoch Times:

*“Amid a wave of “smash-and-grab” robberies and other crimes, a former prosecutor is claiming that more than 50 prosecutors, support, and victim services staff have quit their jobs over San Francisco District Attorney Chesa Boudin’s progressive criminal justice reform policies.*

*While progressive prosecutors contend that “the reason why there’s so many criminals is because our justice system turns them into criminals, it’s a backward argument,” the person said. “They argue that people keep getting arrested because cops keep arresting them and that’s the problem.”*

But what could go wrong with a Communist progressive, radical Islamic extremist like Chesa Boudin whose adoptive parents are Bill Ayers and Bernadin Dorn?

In Los Angeles County Communist progressive prosecutor George Gascon who enjoys getting muddy while wrestling with pigs has all but stopped prosecuting crime, is now spawning other like minded progressive Communists such as Shasta County District Attorney Stephanie A. Bridgett has rolled out several “progressive programs” to provide criminals with *social justice* while the citizens who elected her suffer with her *progressive prosecutions*.
