### NEW CALIFORNIA STATE JOINT RESOLUTION OF THE SENATE AND ASSEMBLY

# **A RESOLUTION TO SELECT PREFERRED INTERIM GOVERNOR**

#### Legislative Background for Senate and Assembly Joint Resolution 19-

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America living in California, all caused by a government of and for a mono-party system led by a tyrannical dictator who openly defies federal law.

On January 15, 2018, an assembly of California citizens met and adopted a formal Declaration of Independence, which included the following declaration in part:

"We are determined to live under a State Government in the United States of America and under the Constitution of the United States....

"Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government....

"When a long train of abuses and acts to seize and hold the people's power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future security. (New California Declaration of Independence of January 15, 2018)

Prior to that declaration, and in the time following, many citizens across the state have conducted weekly readings of grievances against the State of California, and have continued declaring their desire to form a new state that will represent them in a manner that preserves their rights as Citizens of the United States under a constitution that affirms their loyalty and commitment to preserving and defending this republic. It is their determination to remedy the abuse of power by the government of California by execising their right to form a new state as authorized and codified in Article IV, Sections 3 & 4 of the Constitution of the United States.

They have affirmed that this new state, called by their declaration New California, is an authentic state in development, execising its Constitutional Right to form from the State of California. They have also committed to follow the process to form New California as it is authorized and codified in the Constitution of the United States.

As with every new state that has been created and accepted in the union of the United States of America, qualified and committed leadership loyal to the Constitution of the United States is an important first major step that must be acknowedged and addressed. It is therefore proper and necessary that such leadership must be identified and petitioned in order for the new State of New California to be recognized in a formal manner.

**WHEREAS**, California is a mono-party political machine typical of all totalitarian regimes where all political parties within it have failed the people by deliberately destroying the Constitutional design that our Founding Fathers created to insure a republican form of government; and

**WHEREAS**, California has committed to destroy and end all political parties that stand or represent any and all opposition to their socialist, Marxist, post-modern, secular idealisms that are being hammered into place through deliberately unconstitutional legislation and regulatory regimes, most especially through the empowerment of an administrative state; and

**WHEREAS**, it is now clearly recognized that the State of California is a broken and failed state with no future and exhibits no hope or desire to return to the fundamentals of a republican form of government; and

**WHEREAS**, Thomas Jefferson's original final draft of the Declaration of Independence clearly affirmed that "ALL MEN ARE CREATED EQUAL,." and, "That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed,...." This establishes the American founding as a Republic, not a democracy, based upon natural, God-given rights to "Life, Liberty and the pursuit of Happiness"; and

**WHEREAS**, when the State of California was first established in 1849, the first constitution created an interim government with their anticipation that they would soon be admitted into the union of states with the acceptance of their petition for statehood by the United States Congress. On September 9, 1850, Congress acted and accepted California as the 31<sup>st</sup> state of the union, and thus ended the interim government of the state; and

WHEREAS, New California's executive, legislative and judicial regimes shall assume responsibility to govern over and lead their citizens as restrained by their oath of allegiance to protect and defend the Constitution of the United States and the republic. Loyalty to this oath shall be mandatory at every level of government, and shall serve as the foundation to rebuild a new governing regime that will lead its citizens back to a renewed, restored and dedicated enterprise that places the right to life, liberty and the pursuit of happiness and the right to enjoy, own and retain the fruits of their labor and property; and

WHEREAS, no new government can assume as inherent the knowledge and wisdom that will be required to guide in the restructuring, reorganizing, rehabilitation and refocusing that must be instituted through the instituted leadership, even at its interim beginning. Such a task can only be undertaken by a qualified, tested, resolute, uniquely experienced, morally established, committed, person who has demonstrated all the unique traits and skills that will be needed; and

**WHEREAS**, this leadership must be fully dedicated to our natural rights as established by our Creator, without bias or distinction toward divisive classes and ideologies that inhibit, obstruct or defies the fact that all people are created equal, and that the role of government is to secure those rights, without claiming to be the source of the those rights; and

**WHEREAS**, this leadership must also be fully committed to the protection of our national borders, and to the protection and safety of the citizens of New California State; and

WHEREAS, this leadership must also be committed to the protection of private property rights in every way possible, and in preserving the right of all citizens to enjoy the fruits of their labor without the burdens of taxation based upon "social justice," "economic justice," "gender justice" and any of the other political creations to deprive its citizens of their property through any form of unjust eminent domain; and

WHEREAS, because the people of California are suffering under a tyrannical communist state government that promotes a radical agenda in our public schools, colleges, regulatory statutes and administrative governmental industry, which, by its intent, fails to promote a republican form of governance, and forces all citizens to endure an act of war upon their united community spirit to support the unrestrained behavior modification scheme of a utopian egalitarian vision that is deceptively supported by politically-driven science, socialist style central planning and the revising of our historical memory.

### **BE IT RESOLVED**,

By this joint resolution, the Senate and Assembly members of New California, shall hereby recognize our best choice as **James Richard "Rick" Perry**, an individual who has demonstrated the merits in all the ways needed through his service as agriculture commissioner of Texas, lieutenant governor and governor of Texas (three times), and as U.S Secretary of Energy under the current President of the United States, who is the most qualified and mentally and morally equipped person to provide the needed leadership for New California State. We make this resolution with a sincere earnestness that our nation may be blessed through the guidance of a dedicated leader who willfully has declared his loyalty to the United States of America, its Declaration of Independence and its Constitution, and that New California State may remain a free state within this Union.
